- The PM shall track, maintain, and update all employee qualifications and certifications, training logs, student evaluations, instructor evaluations and student handouts, note taking guides, and after-action training reviews.
- The PM shall supervise all Contractor personnel, assign work, provide the COR/KO the task organization of contractors within the Resistance Training Detachment, coordinate with the COR/KO as necessary.

  (ICP) (i.e., successful experience in training SERE instructors to conduct individual and group training

- 7 years of documented and verifiably successful Program Management experience of comparable size, and scope of the requirement defined in this PWS. Experience can be military, civilian, contractor, or a combination of the three.
